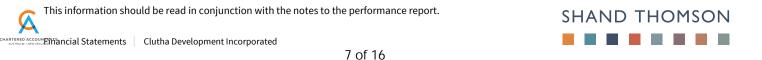

Statement of Accounting Policies

Reporting Entity

Clutha Development Incorporated is an incorporated society under the Incorporated Societies Act 1908. It was established under the constitution dated 24 June 2015 and registered 2 July 2015.

Basis of Preparation

Clutha Development Incorporated has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting – Accrual (Notfor-Profit) on the basis that it does not have public accountability and has total annual expenses less than \$2,000,000. All transactions in the performance report are reported using the accrual basis and historical cost basis of accounting. The performance report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

The financials and other statements are presented in New Zealand dollars and rounded to the nearest dollar.

Particular Accounting Policies

The following particular accounting policies adopted in the financial statements have a significant effect on the results and financial position.

Revenue & Expenses

All income items are recorded in the Statement of Financial Performance in the year that they are earned. All revenue and expenses from all sources are recorded in the Statement of Financial Performance.

■ Goods & Services Tax

The financial statements have been prepared on a "GST exclusive" basis with the exception of accounts receivable and accounts payable which are disclosed inclusively.

■ Income Tax

The entity is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts & Cash

Cash balances in the Statement of Cash Flows comprise of petty cash, cheque or savings accounts, deposits held at call and bank overdrafts.

Accounts Receivable

Accounts receivable have been recorded at their estimated net realisable value. All known bad debts have been written off, and no provision for doubtful debts is considered necessary.

Accounts Payable

Accounts payable are recognised at fair value.

Depreciation

Depreciation has been calculated for all assets on a diminishing value basis over their useful lives as folllows:

Computer Equipment 3 years

Motor Vehicles 4 years

Plant & Equipment 10 years

Exceptional Items

Exceptional items are large income and/or expense items that do not arise as a result of normal business operations and are not expected to recur. Exceptional items are disclosed separately in the statement of financial performance.

Changes in Accounting Policies

There have been no significant changes in accounting policies from those applied last year.

Note 1 - Contingent Liabilities

There were no contingent liabilities at balance date. (2021:nil)

Note 2 - Capital Commitments

Clutha Development Incorporated has a photocopier lease in place with Fuji Xerox for \$117 (GST exclusive) per month for 48 months from April 2021.

Clutha Development Incorporated lease their premises at 16 James Street from Johnstone Group (Balclutha) Ltd for \$33,000 (GST exclusive) per year.

There were no other capital commitments at balance date. (2021:nil)

Note 3 - Related Party Disclosures

The following transactions were entered into by the Trustees' of the Society:

- The Society is insured by FMG Insurance.
- A donation and a membership were paid to Otago South River Care Inc during the year.
- Office space and administration support is provided by the Society to The Clutha Foundation on an "in kind" basis.
- A Suzuki Vitara vehicle was purchased from Balclutha Motors Group Ltd in the 2018 financial year.
- Balclutha Motors Group Ltd completed a warrant of fitness and a service on the Society's vehicle during the year.
- The Society hires facilities from the Clutha Recreation Centre Inc as required.
- The Society receives a significant amount of it's funding from the Clutha District Council.
